SEMMELWEIS AT ICPIC

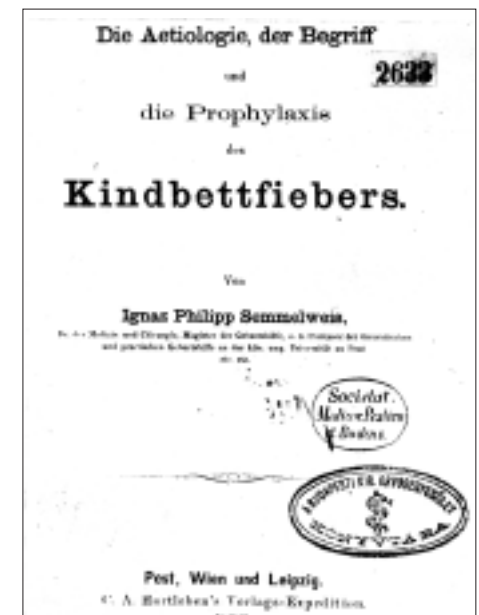
The story of Ignaz Semmelweis' struggle to introduce hand hygiene to the Vienna General Hospital holds a special place in the heart of many infection control professionals. His pioneering use of epidemiology, his determined pursuit of an infection prevention intervention and his vigorous championing of patient safety mean that – despite his faults – he remains an inspiration to those who follow.

It is fortunate that this first ICPIC will coincide with Semmelweis Day on July 1st, 2011. This year also marks a sesquicentenary since the publication of "The Aetiology, Concept and Prevention of Childbed Fever", Semmelweis' weighty monograph.

To mark this auspicious occasion, ICPIC presents:

Semmelweis day: the ten commandments on hand hygiene

This plenary session will involve ten internationally renowned infection control experts presenting their own experiences and opinions regarding hand hygiene promotion. What are the key ingredients to a successful campaign? What does the future hold for hand hygiene?

CALL FOR ABSTRACTS

- Delegates who would like to present their work at the conference, either orally or as a poster, are invited to submit an abstract for consideration by the Programme Committee.
- Abstracts are accepted on a wide range of topics in infection prevention and control of antimicrobial resistance (see page 12). The corresponding topic must be selected to ensure correct scoring of the abstract. The content of the abstract must be topic related.
- Considering the importance of the global aspect of infection control that will be a key part of this meeting, there is a possibility for participants, who don't speak English, to submit abstracts in French. These will be peer-reviewed and those selected will be presented in a dedicated area of the poster session.
- A paper should not be submitted to the 1st ICPI Conference if it has been already presented internationally.
- For standardization, the acceptable length of the abstract is of maximum 2000 characters. This includes the author's details, titles and non-visible characters, such as spaces and line breaks.

Abstracts received after the deadline will not be accepted!

2. TECHNICAL REQUIREMENTS

The internet abstract submission system works best with Internet Explorer 7.0 or higher and Mozilla Firefox 3.0 or higher. Cookies and JavaScript need to be enabled

3. GENERAL

Abstracts can only be submitted **online via the abstract submission form** that can be found in the section "Abstracts" on the official conference website: **www.icpic2011.com**

Abstracts sent by post or email will not be accepted.

No exceptions will be made.



- Abstracts can be saved in “Draft” status to be re-edited and modified until the submission deadline (1 April 2011, midnight CET). Therefore, the submitter will be required to create a user account.
- Abstracts fulfilling all criteria can be saved in “Final submission” status. Only abstracts in “Final submission” status will be regarded as successfully submitted and considered for the conference.
- The submitted / draft abstracts cannot be edited after the submission deadline (1 April 2011, midnight CET)
- The abstract should be structured into the following sections:
 - A title which clearly indicates the nature of the investigation.
 - Introduction should contain 1-2 sentences that clearly indicate the scientific question of the study and its clinical (or other) importance.
 - Methods should contain sufficient information to be able to understand the experimental design, the analytical techniques and the statistics used in the study.
 - Results should contain objective data to answer the scientific question(s).
 - Conclusions should provide only conclusions of the study directly supported by the results, along with implications for clinical practice, avoiding speculation and overgeneralization.
- No tables or figures are allowed in the abstract.
- Conflict of interest: It is the intent of ICPIG to provide high-quality sessions focused on educational content that is free from commercial influence or bias. Thus the submitting author of an abstract is requested to declare any potential conflicts of interest for all authors during abstract submission.
- Abbreviations should be indicated in parentheses following their first mention in the text.
- Trade names cannot be mentioned in the title. However, trade names in brackets will be accepted in the body of the text.
- The submission of an abstract constitutes a formal commitment by the submitting (presenting) author to present the abstract (if accepted) in the session and the time assigned by the Programme Committee. Registration fees will not be waived.
- The presenting author of the abstract must be registered at the conference within 14 days of confirmation of abstract acceptance (the author will benefit from early bird registration fee).
- Please ensure your abstract does not contain spelling, grammar, or scientific mistakes, as it will be reproduced exactly as submitted. Linguistic accuracy is your responsibility. No proof reading will be done.
- No changes can be made to the abstract after the submission deadline.

AFTER THE SUBMISSION

- The reviewers will judge the abstracts according to scientific or clinical value, relevance to ICPIG 2011, conclusions confirmed by objective results, objectivity of statements, originality of work and overall impression.
- The submitting authors will be notified by the end of April 2011 at the email address provided during submission whether their abstract has been accepted.
- If you need to withdraw your abstract a written statement, reflecting the reasons for this decision must be sent to icpic2011abs@mci-group.com not later than 30 April 2011.

PRESENTATION OF ABSTRACTS

- Abstracts can be accepted either as poster or oral communication.
- If your abstract is accepted as a poster, you will be requested to be available for discussion during the corresponding poster viewing session.
- Details on poster format and full presentation guidelines will be included in the notification letter and posted on the conference website.

PUBLICATION

Accepted abstracts will be published in BMC-on-line and be available on site either in the congress abstract book or on CD-ROM. Accepted abstracts will also be available on the ICPIG 2011 website, about one month prior to the congress. Abstracts submitted to the category «Innovation in infection control and antimicrobial resistance prevention» (see page 12) will not be available on the ICPIG 2011 website prior to the congress to ensure protection of intellectual property.

TRAVEL GRANTS

A limited number of travel fellowships will be available for young researcher, or clinicians, below 35 years of age at the time of the conference. Travel fellowships will be awarded to presenting authors of accepted abstracts fulfilling the application criteria. The application for travel fellowship is integrated into the abstract submission. A letter of motivation needs to be included on the submission form as well as a letter of support issued by the mentor / director of the fellow candidate.

THE INNOVATION ACADEMY AT ICPICT 2011

What is the "Innovation Academy"?

The Innovation Academy is a unique opportunity to allow investigators and participants at ICPICT 2011 to participate in a forum which brings together thought leaders in the area of innovations in the practice of infection control and prevention of antimicrobial resistance. It is the first introduction of such an event to an Infection Prevention and Control Meeting and should be an exciting opportunity for all attendees. The Innovation Academy brings together experts from diverse fields that can interact during the planned symposium, the investigator presentations, a social event and a final presentation and awarding of three "Innovation Awards of Excellence" which will be judged by the Expert International Jury of the Academy. The Awards will consist of a certificate, a cash prize and a trophy.

Why should there be an "Innovation Academy"?

The word innovation has its roots in Latin, stemming from innovatus which means to renew or change and although innovation may be seen as a renewal process, it requires a new way of applying decisions or a new application of an existing discovery. It is an important concept in business, economics, engineering, technology and design and is becoming more important in the area of medicine as well. The objective of the Academy is to provide a collaborative interaction between infection control professionals and antimicrobial resistance experts, design experts, technology leaders and business entrepreneurs.

Where is the "Innovation Academy"?

The Innovation Academy will be held during ICPICT 2011 in Geneva and will be clearly identified in the Program. A separate category for the abstract presentations will be provided with details given for the content and attributes to be classified as a participating abstract in this category.

When will the Innovation Academy be held?

The "Innovation Academy " will be held over separate sessions which will include dedicated Poster and Oral presentations, a Symposium which will include speakers from medicine, biomedical engineering, business and technology transfer organizations and a final Awards Ceremony at the cloture of the ICPICT Meeting.

Who may participate?

The Innovation Academy Symposium is open to all participants to the meeting. Investigators who wish to include their abstracts in the Innovation Academy session for oral/poster presentation and compete for the "Innovation Awards of Excellence" must clearly identify the stream (" 14. Category innovation") - to which they are applying and be prepared for judging by members of the Expert International Jury of the Academy and be prepared to attend the Award Ceremony.

How will abstracts be submitted and adjudicated for the Innovation Academy?

Abstract Submissions to the Innovation Academy

- The format will be identical to the standard submission process but they must be clearly delineated as belonging to the category of the "Innovation Academy"
- Additional features for the abstract which may be considered include the following: application of the contribution, originality and creativity, ease of duplication, documented and measurable application, sustainability, cost effectiveness if appropriate and the significance of the contribution in improving the quality of live / of patients

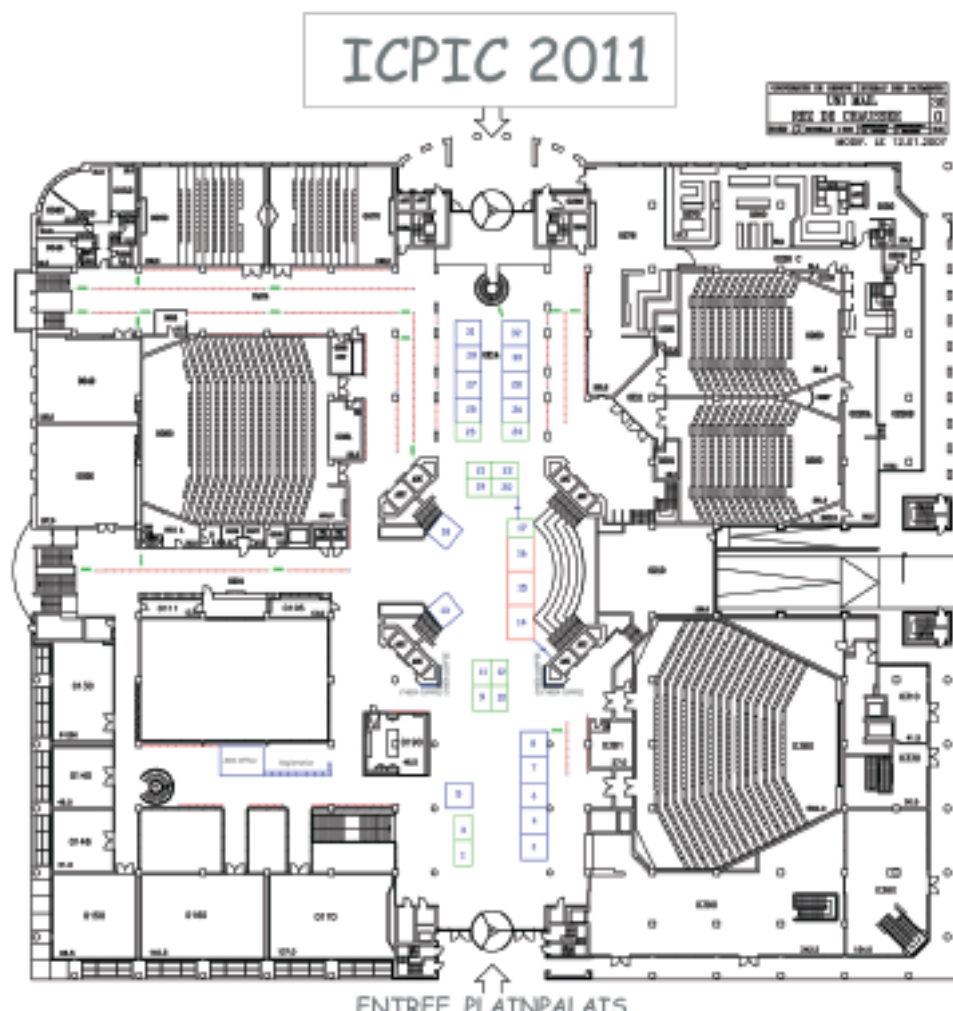
Attributes identified as essential to innovation and for which judging will be applied:

- Transformative of a service or process and not merely additive - the service or process should replace a previous system or prevention model and be improved in objective and measurable ways
- Impactful - attracting the attention of other service providers, researchers, clinicians, and patients
- Pioneering in its scope or in an element, being the first to change the system or process - establishing an approach that will be emulated by others
- Strategic - fulfilling the mission of the organization
- Sustainability - have positive, long-term impact
- Adaptability - could be applied to different settings and resource health systems

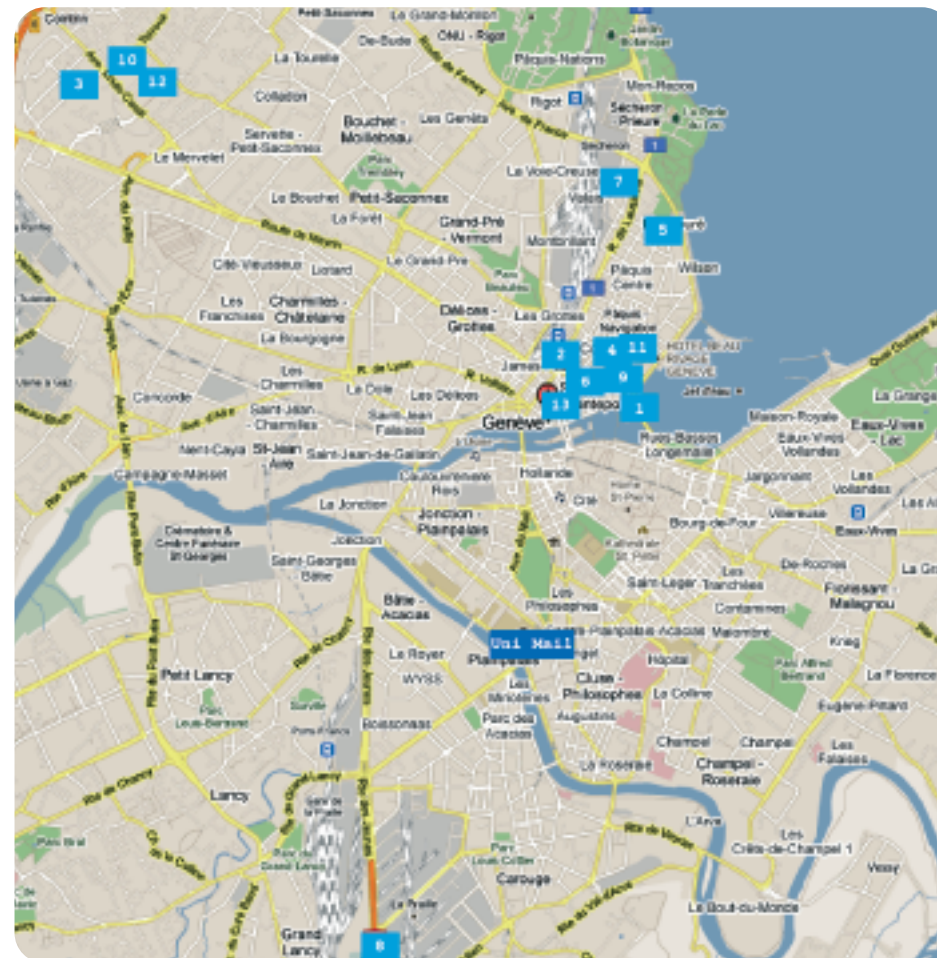
